### STUDENTS FEEDBACK

- 1. Ms. Simrin (TYBSc) gave a overall view of the subject taught in FY, SY & TYBSc.
- 2. She pointed out that there should be more practical and field work in ecology paper.
- 3. Also workshop and classes on Herbarium technique would be useful.
- 4. There should be more time given to perform and complete project report.
- 5. Alumni interactions should be organized every year so the we can get the updated & current information about the subject and career.



#### **ACTION TAKEN**

1. Dr. Vijaya Lobo elaborated on project work for TYBSc.

2. Due to space, chemical and time management project can only be done in a single semester.

3. It was decided that from next time onwards TYBSc project proposal and requirements needs to be submitted at the end of SYBSc before going for vacation. If possible, Summer & Diwali vacations could be utilized for doing project work.

4. Dr. Rajendra Shinde also added on some of the ecological projects which could be taken, like flowering pattern of any species across different areas and correlating it with change

in Light/ or temp etc.

5. Dr. Harinder Singh suggested that Scientist from BARC can come on Saturday & take guest lectures.

6. Alumni interaction for career guidance is arranged for MSc since last 2 years and even the TYBSc students attend it.

### FEEDBACK RELATED TO SYLLABUS

- Dr. Vijaya lobo raised a query regarding Paper SBOT0601, In the Unit-1 of the course, in which topics like phosphate & cation assimilation which were making the unit too heavy, could be removed.
- 2. Also, Paper SBOT0804 & Unit 1 is lighter, needed addition of topics to it.

3. Dr. Harinder Singh suggested that removal of topics like phosphate & cation assimilation from of SBOT0601 unit-1 could be done.

- 4. Dr. Rajdeo Singh suggested that SBOT1002 and SBOT1004 has plant families out of which many families don't occur (Hard to get material for practical's) after Diwali vacation. So, if possible, transfer those families in odd semester so that they can be studied with proper material.
- Dr. Rajendra Shinde suggested to sort families according to season and shift SBOT1004 families to SBOT0904 unit 4 along with the practical's and vice versa.

6. He also suggested that college website need to be updated as it is still showing old data with respect to MSc specialization.

7. He also suggested that instead of learning objectives at the start of every paper needs to be replaced by program objective & its outcomes.

8. Mr. Alok Gude pointed that we should avoid major changes to be done every year to maintain stability, while major changes are possible after every 3 years only.

### **ACTION TAKEN**

1. Paper SBOT0601, In the Unit-1 of the course, in which topics like phosphate & cation assimilation are were removed, by passing the resolution during the BOS meeting.

2. Paper SBOT0804 in which Unit-1 was lighter, so topics on meristem development were added to it, by passing the resolution during the BOS meeting.



- 3. The plant families in courses SBOT1002 and SBOT1004 which have flowering season during rainy season were shifted to SBOT0904 course which is held during rainy season; and the plant families whose flowering season is during winter season were transferred from SBOT0904 to SBOT1004 so as the students could study the plant material in flowering stage. These corresponding changes were also done for the respective practicals of the concerned papers. These changes were passed during the BOS meeting.
- 4. There was very little change done in the SBOT0601 syllabus with removal of few topics; and also small addition in SBOT0804, and only reshuffling of plant families from SBOT0904 to SBOT1004 thereby avoiding too many changes.
- 5. As per Dr. Rajendra Shinde's suggestion, the syllabus was updated on the college website during May 2020.
- 6. Also learning objectives at the start of every paper were replaced by course outcomes.
- 7. Also a foundation was laid to start a new certificate course in Garden & Landscape in collaboration with L.S. Raheja School of Architecture, Bandra, Mumbai.

### Course Parameters:

Since the average rating for point 4 regarding the students' ability to apply theory studies to practical situations (or solution of problems) was the lowest among the scores secured here (3.48), I began to give more policy illustrations with regards to the Economic concepts that I taught the students.

#### Coverage of syllabus:

A majority of the respondents (76%) felt that the coverage was done by me through the lectures itself. However, 4 % felt that the syllabus was not covered at all. I explained to the class in general that though it might seem that I will not be able to cover the syllabus, as the number of economics lectures were lessened due to: Official lecture cancellations (during the two CIAs) and Holidays that coincided with the economics lecture days, I would strive (and I did so) to complete the syllabus in time. Fortunately, I was able to cover the syllabus, without rushing and I did so within just the allotted quota of the net economics lectures.

#### **Evaluation Methods:**

Since 28 % (= 14/50) of the respondents recorded that they were not satisfied with the evaluation methods adopted by me, I re-explained to them the purpose of having a particular marking scheme. I told them that the marking rubrics would compel them to work hard and thereby improve their understanding of macroeconomics.

Finally, I also told them that the evaluation method would help them create an assignment that they would be confident of adding to their CV portfolio

#### Level of interest in the course:

With 26 % of the respondents stating that they had low interest in the economics course, I tried to (once again) convince the class of the importance of a deep understanding of macroeconomics for business students. I also reminded them about the significance of getting a good score in macroeconomics on their 3rd semester marksheet, vis-a-vis their career paths. I also increased the number of suggested readings (especially in the form of newspaper clipping) connected to contemporary economic policies and their outcomes.

Getting them engaged with contemporary economic (global and national levels) issues, hoped would increase their interest in macroeconomics. This was in tune with what was done in the Course Parameter section.
