Ministry of Manpower Development of the Central Government has started programme named National Vocational Education Qualifications Framework from the year 2011 and Finance Department of the Central Government has started National Skill Qualification Framework scheme under it. In relation to it, University Grants Commission has started skills development scheme based on higher education and 1 year Diploma, 2 years Advanced Diploma and 3 years B.Voc. Degree are to be awarded under it. Accordingly University Grants Commission has issued Guidelines for introduction of Bachelor of Vocation

(B.Voc.) programme in universities and colleges under the

National Skills Qualifications Framework. As per eligibility in the said guidelines, some colleges affiliated to University of Mumbai had submitted applications to University Grants Commission. By letter at Ref. No. 2 University Grants Commission has permitted those colleges to start B.Voc. course and necessary recognition with funds has been granted for it.

Under provisions of Sections 82 and 83 of Maharashtra Universities Act 1994, these courses are required to be recognized by the Government and therefore University had submitted the said proposals to the Government under cover of letter referred to at No.1. Said scheme of the University Grants Commission has been started with the object that along with higher education students should acquire skills for securing employment. By taking this object of the scheme into consideration, it is essential to make such an opportunity to the students in the State. At the same time, grant is going to be made available for these courses by the University Grants Commission. In view of these facts, by exercising powers under Sections 82(5) and 83(5) of Maharashtra Universities Act 1994, Government is granting sanction to start the courses mentioned against names of following colleges on permanently non-aided basis.

Therefore concerned colleges should submit an unconditional undertaking on non-judicial stamp paper of Rs.100 to the Regional Joint Director, Higher Education, Mumbai that they will not demand any grant in future.
- University of Mumbai should not start process of affiliation till such time that a certificate is not received that the

above to the Regional Joint Director, Higher Education, Mumbai.

3. It is essential to appoint teachers/non-teaching employees as per criteria laid down by the University and University Grant Commission's criteria relating to educational qualifications etc. Also all other basic facilities should be made available. Regional Joint Director should ensure it and then only submit a certificate to the University.
 4. Colleges should not under any circumstances grant admissions in excess of sanctioned intake.
 5. Till such time that the Colleges do not meet the criteria laid down under Affiliation of Colleges by Universities Regulations 2009, University should not start the process for granting affiliation to the Colleges.
- 2) Without perusing Government sanction order and getting certificate from the Regional Joint Director, University should not take further action for granting affiliation. University of Mumbai should submit compliance report on affiliation to the Director, Higher Education, Maharashtra State, Pune and Regional Joint Director, Higher Education, Mumbai Region, Mumbai.
- 3) It will be responsibility of University of Mumbai and
