

Sub: Your appointment for the post of Full-Time Lecturer for the B.M.S. Self-financing Course.

Dear Mr. Arte,

We are pleased to engage your services as Full-time Lecturer for the B.M.S. Self-financing Course, on the following terms and conditions:

- 1. This contract shall be for a period of about 11 months from the 1st June, 2011 to the 30th of April 2012.
- During the period of contract you shall be paid consolidated professional charges of Rs.30,000/-(Rupees Thirty Thousand Only) per month.
- 3. This is a Non-Government Institutional arrangement and does not come under the service rules of the Government of Maharashtra or the University of Mumbai for its employees. This contract shall stand terminated upon completion of the above period for which you have been engaged. It can also be discontinued by one calendar month's notice given by either of us, if the need arises, or by payment of the equivalent of one month's salary.
- 4. During the period of contract you shall be entitled to 8 days of casual leave & 7 days of sick leave. In case your contract is terminated prior in point of time for any reason whatsoever, leave will be granted on a prorate basis.
- During the period of contract with us, you shall not undertake any employment either on part-time or full time basis with any other employer or company or association.
- 6. You shall abide by the working schedule which may be fixed by the College Management at its discretion during the period of contract. You will be expected to lecture in the BMS course and also to help the BMS Co-ordinator in conducting co-curricular and extra-curricular activities and any other duties assigned to you by the Co-ordinator or Principal, for the smooth running of the College. You will also be expected to take the students on fieldtrips and industrial visits, to guide projects and to motivate and monitor students in their pursuit of all-round development.
- Your appointment is subject to the approval of the University of Mumbai and availability of the requisite workload. You will be required to acquire the qualifications as laid down by the UGC and University of Mumbai, from time to time.
- 8. You will observe the institution's rules and regulations in force during the period of this contract.
