Dear Ms. Soni,

I am pleased to re-appoint you as a full-time lecturer for BMS Self Financing Course w.e.f. 8th June 2009, in the pay scale of 8000-275-13500 at a basic pay of Rs.8,000/- with all permissible allowances as listed hereunder:

1. This is a Non-Government Institutional arrangement and does not come under the service rules of the Government of Maharashtra for its employees. It can also be discontinued by one calendar month's notice given by either of us, if the need arises, or by payment of the equivalent of one month's salary.
2. You shall be entitled to 15 days of Casual Leave and 20 days of Half Pay Leave in an academic year.
3. You shall not undertake any employment either on part-time or full-time basis with any other employer or company or association.
4. You shall abide by the working schedule, which may be fixed by the College Management at its discretion during the period of your service. You will be expected to lecture in the BMS courses and also to help the BMS Coordinator in conducting co-curricular and extra-curricular activities and any other duties assigned to you by the Coordinator or Principal, for the smooth running of the College. You will also be expected to take the students on field trips and industrial visits, to guide projects and to motivate and monitor students in their pursuit of all-round development.
5. Your appointment is subject to the availability of the requisite workload. You will be required to acquire the qualifications as laid down by the UGC and University of Mumbai, from time to time.
6. You will observe the institution's rules and regulations in force during the period of your service.
